Councilmen Stewart, Crutchfield and Lindley voted in favor. Councilman Holland against. Motion passed. After further discussion Councilman Crutchfield repealed his motion for road closure. Councilman Stewart seconded. All in favor. Motion passed. Councilman Stewart made a motion to put up signs stating that effluent water is going to be used on the road that is going through the middle of the City's permitted irrigation site. Councilman Crutchfield seconded. All in favor. Motion passed.

JOINT ELECTION AGREEMENT: Councilman Stewart made a motion to approve the Joint Election Agreement between The City of Mertzon and the Irion County ISD. Councilman Lindley seconded. All In Favor. Motion passed.

PRIOR MEETING MINUTES: Councilman Stewart made a motion to approve April 4, 2022 minutes as written. Councilman Lindley seconded. All in favor; motion passed.


DAILY OPERATIONS UPDATE: Information presented by Supervisor Steve Thompson
