Service Agreement

I. PURPOSE

The City of Mertzon is responsible for protecting the drinking water supply from contamination or pollution which could result from improper plumbing practices. The purpose of this service agreement is to notify each customer of plumbing restrictions which are in place to provide this protection. The utility enforces these restrictions in order to ensure the public's health and welfare. Each customer must sign this agreement before the City of Mertzon will initiate service. In addition, when service to an existing connection has been suspended or terminated; the water system will not re-establish service unless it has a signed copy of this agreement.

II. PLUMBING RESTRICTIONS

-The following unacceptable plumbing practices are prohibited by state regulations:

- A. No direct connection between the public drinking water supply and a potential source of contamination is permitted. Potential sources of contamination shall be isolated from the public water system by an air-gap or an appropriate backflow prevention device.
- B. No cross-connection between the public drinking water supply and a private water system is permitted. These potential threats to the public drinking water supply shall be eliminated at the service connection by the installation of an air-gap or a reduced pressure zone backflow prevention device.
- C. No connection which allows water to be returned to the public drinking water supply is permitted.
- D. No pipe fitting which contains more than .25% lead can be used for the installation or repair of plumbing at any connection which provides water for human use.
- E. No solder or flux which contains more than .2% lead can be used for the installation or repair of plumbing at any connection which provides water for human use.

III. Service Agreement

- A. The Water System will maintain a copy of this agreement as long as the Customer and/ or the premises are connected to the Water System.
- B. The Customer shall allow his property to be inspected for possible cross-connections and other potential contamination hazards. These inspections shall be conducted by the Water System or its designated agent prior to initiating new water service, when there is reason to believe that cross-connections or other potential contamination hazards exist; or after any major changes to the private water distribution facilities. The inspections shall

- be conducted during the Water System's normal business hours.
- C. The Water System shall notify the Customer in writing of any cross-connections or other potential contamination hazard which has been identified during the initial inspection or the periodic re-inspection.
- D. The Customer shall immediately remove or adequately isolate any potential cross-connections or other potential contamination hazards on his premises.
- E. The Customer/Property owner shall, at his expense, properly install, test, and maintain any backflow prevention device <u>required</u> by the Water System. Copies of all testing and maintenance records shall be provided to the Water System annually.

PLEASE UNDERSTAND THAT THE BACKFLOW PERVENTION DEVICE ON YOUR SERVICE LINE CREATES A CLOSED SYSTEM. THIS MEANS THAT YOU NEED TO BE SURE THAT YOUR WATER HEATER IS IN PROPER WORKING ORDER AND HAS BEEN PROPERLY INSTALL WITH EXPANSION PROVISION IN CASE THE WATER HEATER OVERHEATS.

F. From time to time the City finds it necessary to install backflow preventers and/or pressure reduction vales to prevent water from back flowing into the City water mains and/or to reduce water pressure on the Customers waterlines. Either of these devices will create a closed system.

PLEASE UNDERSTAND THAT THE BACKFLOW PERVENTION DEVICE ON YOUR SERVICE LINE CREATES A CLOSED SYSTEM. THIS MEANS THAT YOU NEED TO BE SURE THAT YOUR WATER HEATER IS IN PROPER WORKING ORDER AND HAS BEEN PROPERLY INSTALL WITH EXPANSION PROVISION IN CASE THE WATER HEATER OVERHEATS.

IV. ENFORCEMENT

If the Customer fails to comply with the terms of the Service Agreement, the Water System shall, at it option, either, terminate service or properly install, test, and maintain an appropriate backflow prevention device at the service connection. Any expenses associated with the enforcement of this agreement shall be billed to the Customer.
