ORDINANCE # 12-4-23: Councilman Elliott made a motion to adopt Ordinance #12-4-23 authorizing the issuance of City of Mertzon. Texas Combination Tax and Surplus Revenue Certificates of Obligation, Taxable Series 2024A, in the principal amount of \$2,085,000 and awarding the sale of such Certificates of Obligation to the Texas Water Development Board.
