ROAD CLOSURE FOR 4TH OF JULY PARADE: Councilman Lindley made a motion to allow residents to have 4th of July parade starting at W. Fayette Avenue and Fifth Street then turning East on Duncan Avenue ending at the park on Duncan Avenue. Councilman Councilman seconded. All in favor. Motion passed.

TAX ASSESSOR CONTRACT FOR 2024 TAXES: Councilman Lindley made a motion to approve the contract with Irion County Tax Assessor for assessing and collecting the 2024 taxes. Councilman Crutchfield seconded. All in favor. Motion passed.

METER REPLACEMENT PROJECT: Councilman Lindley made a motion to accept the bid for the new water meter project from Ferguson Waterworks, and allow \$36,058.58 to be withdrawn from the \$60,000.00 CD located at The First National Bank of Mertzon. Councilman Crutchfield seconded. All in favor. Motion passed.

RESIDENT PLAN FOR ROW LANDSCAPING: Councilman Councilman made a motion to accept the submitted plan for ROW landscaping on W. Fayette. Councilman Crutchfield seconded. All in favor. Motion passed.

FINANCIAL DOCUMENTS: Councilman Lindley made a motion to approve all financial documents. Councilman Crutchfield seconded. All in favor; motion passed.
