ICISD LEASE AGREEMENT: Councilman Stewart made a motion to allow the Mayor and City Attorney to negotiate with the ICISD and their attorney a new lease for the football field. Councilman Holland seconded. Al in favor, motion passed.

SELECT ADMINISTRATION SERVICE PROVIDER: Councilman Stewart made a motion to pass Resolution 11-05-21 and authorize Mayor Taylor and Administrator Wardlaw to negotiate percentage for administrative fees with a cap at 6%. Councilman Matthews seconded. All in favor; motion passed.
